Accuplacer testing replacement - Marilyn

- **Dev Ed Taskforce recommendation.**
- **Assessment needs to be aligned with the curriculum.**
- **Can't be a generic assessment.**
- **Needed multiple measures.**
- **Accuplacer scores in Colorado have never been validated.**
- **Students should be placed at highest level possible.**
- **Change in philosophy, instead of saying "No" to getting a student in college level class, this philosophy says "Yes" to getting students into college level classes.**
- **Pearson publishing came to the taskforce and formalize an assessment, didn't work out though.**
- **Need an RFP for a vendor, started in February 2012. All of the VP's of instruction had the opportunity to look at the RFP.**
- **McCann & Associates won the RFP.**
- **5 year contract.**
- **Analyzes writing samples, computer based, diagnostics also available.**
- **2 Writing samples, 1 math, 1 reading.**
- **Kuddos to Bitsy Cohn for her leadership on this project**
- **January 25, 2015 roll out date at community colleges across the State of Colorado, for summer implementation**
- **Is there a policy for retesting? The recommendation was there needs to be some standardization across the colleges. In the past there has been inconsistency. At this point there isn't anything, but should be a long term thought.**

General Education Requirements for AA/AS degree

- **SFCC has a more stringent requirement for general education courses than CCHE has.**
- **Do we want to create a committee to address this?**

AP test scores – informational handout

- **Number of courses gathered together how cut score is accepted at colleges.**
 - **If there is no score it is shown in green, 2 or higher shown in red, 3 in white and 4 or 5 is in yellow.**
- **Inconsistency with how scores are being accepted at institutions.**

2:2 minutes review

- **Copies of the minutes.**
- **Break into groups to find any items which need to be completed.**

Colleges indicating they can NOT add a certain prefix/discipline to their institution. How does this impact our 80/20 rule?

- **Creates a similar to identical course**
- **If administrators are restricting what disciplines/prefixes are adopting at their institution, this impacts the common course numbering philosophy of no duplication.**
- **We need our VPI's to discuss this at their level.**
- **It can present credentialing problems.**

Additional notes:

- **When a class shows up on the BB, but is denied or not approved, it still needs to sit on the BB for at least the one year as it may be offered at the originating institution. It goes into the archived section.**
- **If a course is sitting on the BB under proposed, can I build the course in Banner? If it is new it will show up, if it is changed, the change won't take effect until the academic year ends.**
 - **SFCC sometimes comes across as difficult to get a course through. Faculty need to understand we hold everyone to the same level.**
 - **Some faculty get upset that the course gets sent back because the template is incorrect. Faculty need to make sure they are using the most current template and not reuse from a previous course which may have been submitted years ago.**
 - **Institutions need to check their forms before sending them to the system. Not all institutions send the forms to Angie in a consistent manner.**
 - **le: FRCC sends the system form along with their institution form.**
 - **Need a process: What are the steps you follow? What is necessary? Martha will send forward her institutions examples.**
- **HIT 122 – change from 2 to 3 credits. Need change effective to Spring 2015 instead of Summer 2015.**
- **GT Pathways**
 - **March 13, 2015 – Final Submissions for GT pathways due date.**
 - **List generated of what GT courses haven't been offered in the last 12 months and the past 5 years.**

- Jerry sent the VPI's the list, however, some courses on that list have indeed been offered.
 - Any which haven't been offered will no longer remain GT Pathways courses.
 - Should list all GT courses on the website.
 - There is also a list of "Coming Soon" courses, Jenny/Angie will update this list too.
 - New website has been difficult to navigate; this is a work in progress.
 - **HIS 246 History of Mexico GT course:**
 - Is this a new or old course? It's been in CCCNS for a while.
 - The HIS discipline agreed that new courses would be using new procedure.
 - The competencies no longer meet our criteria: ie: Understand is used.
 - Ask the History discipline to clean up the competencies of the database.
 - **History Discipline Course Clean up**
 - If the content isn't changing, but the wording is changing, these changes can go through Jenny/Angie.
 - If removing or adding competencies then yes, it would need to go through an institutions curriculum committee.
 - **80/20 rule**
 - The 20 was designed to allow faculty to place their own content into their course.
